



APPLICATION FOR FLORIDA AFL-CIO

AFFILIATION

Per Capita Dues: The monthly per-capita dues payments shall be paid to the Florida AFL-CIO at eighty (80) cents per member per month. Per capita dues payments shall be due and payable on the first of each month and shall be based on the local's membership during the previous month. Of the eighty (80) cents in dues per member received, fifty (50) cents shall be retained by the Florida AFL-CIO and thirty (30) cents shall be distributed to the CLC in which a member resides. **(See page 2 for more details.)**

Local, District or Statewide councils shall pay into the treasury of the Florida AFL-CIO the sum of fifty (\$50) dollars annually, which sum shall be due and payable for the year in January.

New Affiliations: Local Unions desiring to affiliate shall pay one (1) month's per capita dues at the time of affiliation, based on their previous month's membership.

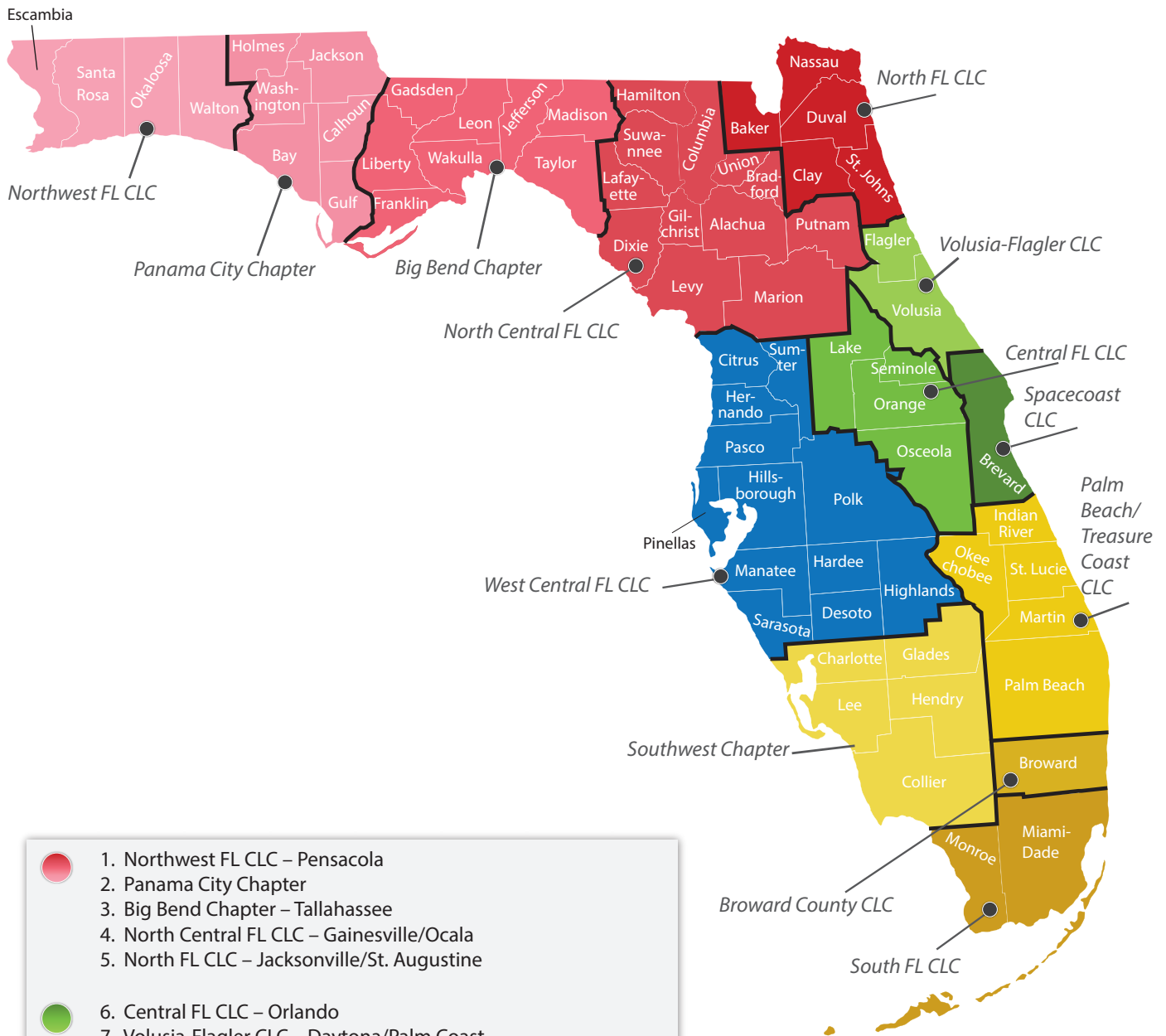

AFFILIATION

Of the eighty (80) cents in dues per member per month received, fifty (50) cents shall be retained by the Florida AFL-CIO and thirty (30) cents shall be distributed to the Central Labor Council (CLC) in which a member resides. The thirty (30) cents CLC per capita distribution is based on the home address of each individual member of a local. Depending on the home addresses of individual members, a local's payments may fall under the jurisdiction of one or several of our ten (10) Central Labor Councils.
